The meeting started with welcome speech of Dr. O.P. Verma, General Secretary. He welcomed all the above members for celebrating get together event by joining virtual meeting. He also felicitated and warm welcomed to all elected members for becoming important nerves of this Executive Committee. He congratulated to all for their well-deserved and overlong success. He also informed the objective of the meeting which is to understand the showcase contents and related solutions to the requirement of Pensioners of C.C.R.H. and challenged faced by them in communication about their medical insurance, submission of life certificate online and funds generation.

Dr. M. Prakash Rao, President, CCRHPWA presided the virtual meeting. He delivered the Presidential speech and spoken about the importance of the Executive Committee. He also appealed to the members for their co-operation and all kind of support in achieving the goals of the Association.

Thereafter, Shri D.R. Sarang, Treasurer presented detailed statement of accounts of the Association. He informed the Committee about the available funds deposited in the Bank, which is about Rs. 2,61,000/- including two fixed deposits for a sum of Rs. 50,000/- and Rs. 80,000/- respectively. He also informed the expenditure incurred in the meeting held at Chennai, which is about a sum of Rs. 1,28,000/-.

Thereafter, the agenda items were discussed and the views and experiences of the members were noted. In the meeting, the following matters were decided and approved by the present members:-

- a) The account of Association existing in Federal Bank, Chingavanam (Kerala) may be transferred to Dwarka Branch of Delhi.
- b) The matter related with the Medical insurance is pending in the High Court of Telangana, Hyderabad. The date of hearing is still awaited. The said matter may be followed up very seriously on the line of the judgement made in favour of C.C.R.U.M.. Shri S.S. Bhutani explained about the all pending matters of CCRHPWA.
- c) Mr. Dinesh Bhatia apprised the Committee about non-facilities of CGHS in the peripheral area excluding Delhi and NCR. The Committee has assured to the members that the matter will be taken up very seriously and will be applied to the higher authorities in Nirman Bhawan. Shri R.K. Saxena also participated and discussed in the deliberations.
- d) Mr. Dinesh Bhatia also informed to the Committee for implementation of Patient care allowance in the Council for the Pensioners during their service period.
- e) The President has suggested for creation of new group of “CCRHPWA Forum” for sharing social message, which is approved.
- f) With the permission of the Chair, Dr. Hari Singh also suggested to organize a physical meeting of the Executive Committee in the month of October/November, 2023 for 3-4 days somewhere in India as well as abroad. General Secretary suggested for organizing a family trip-cum-Executive Committee meeting in Bali, Indonesia on the personal expenses of each members whosoever may like to join.
- g) Dr. B.S. Arya and Shri R.K. Dua also detailed the activities of Association. The meeting ended with a vote of thanks delivered by Shri R.K. Dua, Joint Secretary and he will talk to D.G., CCRH for exemption of Registration fee for Pensioners of CCRH in participation in World Homoeopathy Day scheduled to be held on 10.04.2023.
