Dr. Hari Singh, Chief Patron was also present.

The meeting started with a welcome speech of Dr. M. Prakash Rao, President, CCRHPWA, who presided the virtual meeting. He welcomed all the above members to join the online meeting. He delivered the Presidential speech and spoke about the activities of the Association. He also appealed to the members for their co-operation and all kinds of support in achieving the goals of the Association.

Thereafter, Dr. O.P. Verma, General Secretary, also welcomed all. He paused the meeting for a moment of silent prayer in honor of the departed soul of Late Mr. Sajimon.

He addressed all members by sharing the follow-up of the Minutes of the meeting held on 10.06.2023. He apprised that:

- The committee has approved the revised rates of membership subscription, which was countered by one of our members Sh. MSP Panicker, Vice President, CCRHPWA. He suggested that the membership fees need to be approved in the General Body meeting. So that the revised rates of membership fee will be ratified in next General Body meeting, but it is effective with effect from 1st June 2023.
- CCRH has received a letter from Ministry of AYUSH regarding the lifetime subscription of CGHS for the pensioners.

- c. Mr. Shyam, Website Developer, has not yet sent a formal quote of Rs. 22/- per new page (addition/deletion/new page) duly approved by the Committee.

- b) The physical meeting of the Executive Committee will be organized in the month of December 2023 at Delhi.
- c) Mr. Shyam, Website Developer , may be approached to send a formal quote for maintenance of CCRHPWA website.
- d) The Treasurer was requested to post the list of members whosoever have not yet renewed their membership on the group of CCRHPWA.
- e) A letter may be sent to the Secretary General, National Federation of Pensioners of AYUSH Council regarding the clarification of the Court Case matter.

The meeting ended with a vote of thanks by Sh. R. K. Dua, Joint Secretary.
